ESTABLISHED IN MEMORY OF OUR FALLEN LP/AP

Our community mourns the passing of all Loss Prevention (LP) and Asset Protection (AP) professionals.

As a profession, we cannot allow the families of our fallen colleagues and friends to mourn their losses without voice or support. Our profession has united to offer assistance to families who suffer a loss of their loved one while conducting the duties of our profession.

In addition to distributing funds to the families of the fallen, the LPBF was established to provide financial grants to eligible participants who experience a verifiable economic hardship as a result of qualifying circumstances. Situations that could qualify for a grant include serious medical issues, death of a dependent, natural disaster, no permanent shelter, homelessness etc. Applications for assistance made to LPBF will be kept confidential except as required by law.

We ask that the LP/AP community at large offer their assistance in helping these families who suffer the loss of their loved ones or to support those who experience a serious economic hardship by making a generous loving donation.

LPBF seeks individuals, organizations and businesses who can donate to the fund. We also need volunteers to help raise funds and promote awareness.

The LPBF continues to accept your undesignated gifts for this purpose throughout the year.

FUNDS DISPERSED

Since the LP Benevolent Fund's establishment in late 2012, we have already helped four families who have suffered extreme loss. For example, the LPBF was able to help the families of Luis Jhon (\$2,000) and of J.D. Ferguson (\$10,000), both slain while attempting to confront a suspect. We were also able to assist the Angelo Longo, Jr. family. Angelo (\$2,000), an LP professional, was lost to his family while he was working for his company.
